**Probable Cause Affidavit**

Before me this date personally appeared Officer C Anterio who being first duly sworn deposes and says that on 07 day of 09 (year) 2017 at 47801 W State Road 84, Davie, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

On 09/07/2017 at approximately 1900 hours, while working vehicle checkpoints at the Miccosukee Service Plaza, located at 47801 W State Road 84, Davie, FL, 33327, due to the potential hurricane and large lines of cars attempting to refuel, I observed a 2016 white, Toyota Corolla bearing NY Tag HHB 1909, driving erratically in the parking lot. The lines for gas were specifically made to come into the one way south entrance of the plaza, and were brought through the large dirt lot located to the south side of the building. The vehicle was traveling the wrong way against traffic then made a sharp turn into the middle of the dirt lot. The vehicle then proceeded back northbound through the lot at a speed which was unsafe for conditions due to the large number of vehicle, people on foot, and Miccosukee Police Officers directing traffic.

Before me this date personally appeared Officer C. Anterio who being first duly sworn  
deposes and says that on 07 day 09 2017 at 47801 W State Road 84, Davie, FL (crime location) the  
above named defendant committed the above offenses charged and the facts showing probable cause to believe same are as follows

The vehicle attempted to drive around Detective M Wright who was wearing a Miccosukee Police jacket, and a bright green high visibility traffic vest. Detective M Wright and myself, were able to get the vehicle stopped in time before it proceeded into oncoming traffic. Several commands were given to the driver, who was later identified by her New York Driver's License as Gulsun Rose Lambert, to roll her window down to speak with officers. Mrs Lambert seemed confused by the contact, laughing and disrupting the flow of traffic and the Plaza's ability to provide gas safely to other patrons. Once Mrs Lambert rolled her driver's side window down, a strong odor of an alcoholic beverage was smelled emanating from her breath and person. While speaking to Mrs Lambert, she had bloodshot watery eyes, and appeared to be looking past me rather than at me while I was conversing with her. Mrs Lambert often times laughed at the situation, stating she did nothing wrong. I observed in plain view a large bottle of CA' Di Rajo Prosecco, an alcoholic beverage, in plain view in the passenger seat of her vehicle. When I asked Mrs Lambert about her open bottle of Prosecco, she stated it was sparkling wine and non-alcoholic. Mrs Lambert stated she had just purchased the bottle inside the business, and had been drinking it. The Prosecco bottle was three quarters empty. Also located in plain view was a clear plastic cup in the center console, which contained several fluid ounces of the wine bottles contents.

At that time, Mrs Lambert was asked to exit the vehicle. Mrs Lambert complied. When Mrs Lambert exited the vehicle, she had on no shoes, and appeared uneasy on her feet, often times leaning her back on her vehicle. At that time, I asked Mrs Lambert if she would submit to Field Sobriety Exercises, at which time she stated she would.

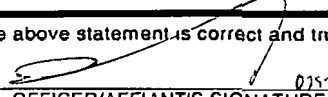
The following Field Sobriety Exercises were conducted:

**Horizontal Gaze Nystagmus**  
Mrs Lambert exhibited lack of smooth pursuit in both eyes. Mrs Lambert showed nystagmus at maximum deviation in both eyes. Mrs Lambert displayed an onset of nystagmus prior to 45 degrees.

**One Leg Stand**  
Mrs Lambert was asked to stand with her feet together and arms down at her side, instead Mrs Lambert placed her arms straight out and had to be re-instructed to place them down at her side. Mrs Lambert began swaying while standing with her feet together. Mrs Lambert picked her right foot up off the ground, and began the exercise. Mrs Lambert did not count out loud as instructed. Mrs Lambert swayed while balancing. Mrs Lambert used her arms several times to balance, and put her foot down after several seconds, stating "Is this a joke" and began laughing.

I explained to Mrs Lambert that I was giving her a chance to dispel my fears that she was intoxicated while operating a motor vehicle. I explained to Mrs Lambert that if she did not complete the exercise, then I would have to make the decision to take her to jail on what evidence I had. Mrs Lambert stated "I am looking for a safe place, don't give me any ideas."

Anterio who being first duly sworn deposes and says that on 07 day 09 2017 at 47801 W State Road 84, Davie, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe same are as follows

Walk and Turn  
Mrs Lambert took 10 steps each way during the exercise, when instructed to only take 9 On Mrs Lamberts first set of nine steps, she continuously stepped on her toes, not making heal to toe steps as instructed Mrs Lambert raised her hands several times to balance herself Mrs Lambert did not complete the turn as instructed, causing her to step off the line and raise her toe which was suppose to remain on the line On Mrs Lambert's return trip, she missed heal to toe on steps 5 and 7

At that time, Mrs Lambert was taken into custody for Disorderly Intoxication and suspicion of D U I Due to the inclement weather related to the mpending hurricane, the Broward Sheriff's Office BAT center would not respond and was unable to assist with a Breath Test The Florida Highway Patrol advised they could not assist as well As a result, Mrs Lambert was transported to the Miccosukee Police Department's Krome Substation to administer a breathalyzer test, which was approximately 1 hour away Due to the drive time to the location, and waiting for a esponse from both BSO and FHP, the Breath Test wasn't administered until 2058 hours This test was administered by BTO Sergeant A Prozzillo, which registered .000 BAC Because of the amount of time elapsed between the arrest and the actual Breath Test sample provided, it was believed Mrs Lamberts impairment was unable to be detected

Mrs Lambert was charged with Disorderly Intoxication Mrs Lambert was issued a citation's for Careless Driving, and Open Container Mrs Lambert was transported to the Broward County Main Jail without incident
