The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a silver Lincoln SUV bearing FL tag QVDD64. The defendant was observed driving eastbound on Adamo Dr and weaving in her lane causing her tires to cross the lane lines on multiple times and at one point leave the roadway and drive into the dirt. The vehicle had inconsistent, varying speeds and traveled above the posted speed limit (paced at 60 mph in a 50 mph zone). A traffic stop was conducted for the speeding violation as well as to check on the welfare of the driver. Upon contact, the defendant exhibited indicators of impairment to include a blank stare, glassy eyes, a bar bracelet on her right wrist, the odor of an alcoholic beverage emanating from her breath, unsteadiness on her feet and admission of drinking. The defendant participated in SFSE's which showed further indicators of impairment and was subsequently arrested for DUI. The defendant provided breath samples of .111/ .124. The defendant was ID'ed via FL DL.
