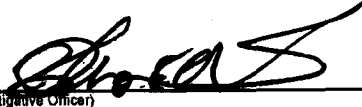

The following incident occurred in unincorporated Boca Raton, Palm Beach County, Florida: On Tuesday, July 26, 2022 at approximately 20:27hrs, while conducting traffic enforcement in the area of State Road 7 and Glades Rd, I observed a black BMW M3 bearing FL Tag: traveling southbound on State Road 7. I observed the vehicle to have excessively dark tints on the front and rear windows of the vehicle. I also observed the tag to be obscured by a tinted screen. After a query of the tag through NCIC/FCIC, it was discovered that the tag was expired as of June 21, 2022. I conducted a traffic stop on the vehicle and made contact with the driver who was identified by FL DL to be Hassan Ahmad Alba (06/21/2002 W/M). Hassan was the single occupant of the vehicle. It should be noted that upon approach to the vehicle I could smell a strong odor of what I knew to be Marijuana based on my training and experience. While attempting to gather information from Hassan, Hassan spontaneously uttered that he had two firearms in the vehicle. One firearm in the glove compartment and one the driver's side door next to his left leg. Hassan was asked to step out of the vehicle in which he complied. Hassan was detained and not free to leave. When asked if there was any marijuana in the vehicle he stated "There shouldn't be". When asked why the vehicle smelled of marijuana, Hassan stated he doesn't smoke however he let a friend in West Palm Beach, Florida drive the vehicle and that he just got his vehicle back. Based on the above investigation, a search of the vehicle was conducted. A loaded black Glock 42 .380 caliber (S/N: AAPD966) was located in the driver side door unsecured and readily accessible which had a round in the chamber and next to it was a large amount of US currency. The currency was counted and verified by D/S Gomez #39619 and myself. A black ski mask was located under the firearm. A second firearm, a loaded Silver and Black Glock 43 (S/N: AFWB315) was located in the glove compartment of the vehicle. A black cylinder container was located under the front passenger seat. In the container was 2 pre rolled marijuana cigarettes. It should be noted, Hassan is 20 years of age and is not legally able to obtain a Florida Concealed Weapons Permit. Hassan was placed in handcuffs which were checked for proper fit and placed into the backseat of my marked patrol vehicle. Hassan was transported to District 7 substation for processing. Hassan was later transported and turned over to the Palm Beach County Jail. Based on the above investigation and observations, I find Hassan knowingly carried on or about his person a firearm. The firearm was concealed from the ordinary sight of another person. At that time, Hassan was not licensed to carry a firearm.
