The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 02/22/2022, at approximately 0203, the affiant conducted a traffic stop a black Honda Civic, bearing Illinois Tag Z642809 (VIN:19XFC2F72GE002030), for failing to stop at a steady red light. Upon contact with the defendant, the affiant detected the distinct odor of an alcoholic beverage emanating from his breath, observed his eyes to be red/bloodshot and watery, his speech to be slurred, him to fumble for requested documents, and his balance to be unsteady. The affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant was transported to CBT, where he refused to provide lawful sample of his breath after Implied Consent was read and understood. The defendant was positively identified via his valid Illinois driver's license.
