The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 4/9/2022, at 0109 hours, I conducted a traffic stop on the defendant for limitations on overtaking, passing, or changing lanes at Dale Mabry Hwy N / Kirby St W. Upon contact with the defendant, the defendant had glassy/watery eyes, slurred speech, and the distinct odor of an alcoholic beverage emanating from her breath.
