The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On listed date and time at listed location co-affiant conducted a traffic stop on a black Toyota four door bearing FL tag #LFPK53 for driving the wrong way on a one way street, driving westbound on an eastbound roadway. Affiant responded and assumed the investigation. Upon making contact with the defendant who was the driver and sole occupant of the vehicle. The defendant had the distinct odor of alcoholic beverage coming from her person. The defendant had glassy and watery eyes. The defendant also had slurred speech. Defendant was requested to exit the vehicle where she was observed to be unsteady on her feet often reaching for the vehicle in an attempt to steady herself. The defendant agreed to perform Standardized Field Sobriety Exercises which she was unable to successfully complete. The defendant was placed under arrest for DUI and into the back of a marked patrol vehicle. The defendant was transported to Orient Road Jail Central Breath Testing where she was requested to provide two breath samples and a twenty minute observation period was completed. After the observation period the defendant provided two breath samples resulting in .188 and .198. Defendant positively identified via FL DL #S455336716700.
