The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a black 2007 Jeep bearing a Florida license plate of 85KHU. He was traveling north on Howard Ave and made a left turn from a through (northbound) lane. This intersection has a designated left turn lane and the defendant failed to use that lane. This resulted in an improper left turn. As I followed the vehicle west on Kennedy Blvd, I paced it traveling 60 MPH in a posted 40 MPH zone and the vehicle was weaving back and forth. A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, a strong odor of an alcoholic beverage, a drunk-like appearance, and an admission to consuming alcohol (two beers). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .157 and .140. The defendant was identified by his FL DL.
