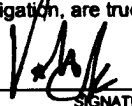
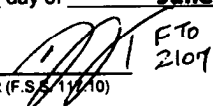

It should be noted, due to a language barrier a family member was needed to translate. FTO Thomas and your writer, made contact with the victim, Ru Chen (W/F,11/27/76) who provided a sworn statement captured audially and digitally on BWC and was translated by Linbin Guo (W/M,3/25/90).

Chen was on her way home with her boyfriend of five years, Huang XueQin (W/M,3/30/74), at approximately 0130hours. XueQin was intoxicated. Chen said once they arrived, she proceeded to go upstairs in her bedroom to go to sleep, while Huang stayed downstairs and talked to some friends. Chen stated that she was in her bed sleeping when Huang came upstairs in the bedroom, pulled the covers off and began to hit her multiple times with a closed fist in her face. Chen advised that she was attempting to leave the room however XueQin continued to grab her by her left arm causing her to get scratched. During this XueQin grabbed Chen's cellphone and threw it. Eventually Chen was able to escape XueQin's grasp. Chen then ran to grab her phone and run downstairs where she ran next door to 2098 Tarpon Lake Way, West Palm Beach, Palm Beach County, Florida and called her WPBPD.

FTO Thomas and I visually inspected Chen and observed a fresh red mark/bruise on the lower left side of her neck and fresh red scratch marks/whelps on her left arm. The injuries were digitally photographed and uploaded onto Evidence.com.

FTO Thomas and your writer, attempted to fact-finding interview with XueQin. XueQin advised he did not want to speak and gestured with both hands to arrest him. Huang was placed in handcuffs which were checked for proper spacing and double locked. XueQin was placed in the rear of our marked patrol vehicle. FTO Thomas and your writer attempted to advise XueQin of his Miranda Rights by reading them from a pre-printed Miranda Warnings card; however, XueQin would not allow us to as he would not stop speaking.

As a result of this investigation, probable cause exists to charge XueQin Huang with one count of Domestic Battery per FSS 784.03(1A1).
