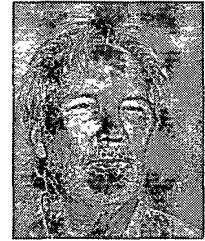

Before me this date personally appeared SUAREZ, RENE (17050) who being first duly sworn deposes and says that on 12 day of September, (year) 2017 at 210 COMMERCIAL BLVD, LAUDERDALE BY THE SE, FL 33308 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Mr. Smith II was very intoxicated and having a rough time standing up. Deputy Guillermo Valdes (CCN# 5675) and I were able to get Mr. Smith II up onto his feet and lean him against the patrol vehicle. Mr. Smith II was very condensing, screaming, obnoxious, using profanity against the Deputies and acting disorderly at which time patrons at the Ocean Mist Pub & Bar walked outside and patrons across the street were stopping to see the incident.

This Deputy patiently put up with Mr. Smith II condensing manner and abusive language while attempting to get in contact with a family member on his cell phone to pick him up. While in the process of attempting to get a family member to pick him up, Mr. Smith II decide to swing at this Deputy with his right hand striking this Deputy on my arms.

Mr. Smith II was arrested, transported to Broward General Hospital for medical clearance and then to the Broward County Jail.
