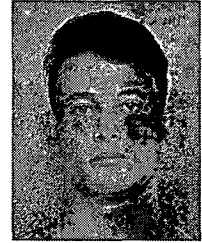

Before me this date personally appeared ODOR, ROBERT (18133) who being first duly sworn deposes and says that on 21 day of January (year) 2021 at 6300 N FEDERAL HWY, FORT LAUDERDALE, FL 33308 (crime location)

the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

also heading northbound on N Federal Highway I continued to follow the Mazda and observed the Mazda veer into the left lane, then back into the center lane, and then he veered into the right lane without using any signals I also observed the driver's vehicle exceeding the posted speed limit of 45 mph in the middle lane of the 6300 block of N Federal Highway, I activated my radar and it indicated a speed of 60 mph I made a traffic stop on the vehicle at the 1200 block of S Federal Highway in Pompano Beach, Florida

I made contact with the defendant and asked the defendant where he was coming from and he replied, "from there" I asked him where exactly and he stated Fort Lauderdale He finally stated a restaurant in Fort Lauderdale During my interaction with the defendant I observed an odor of an alcoholic beverage emitting from the defendant's breath, glassy eyes and a yellow wrist band that is consistent with a nightclub/bar I asked the defendant if he had been drinking and he said no that he was only 19 years old

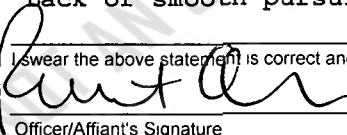
I had the defendant step out of vehicle, and I asked the defendant if he would do some sobriety exercises and he stated yes

I demonstrated and explained the following exercises

Horizontal Gaze Nystagmus (HGN)
(checked for equal pupil size, resting Nystagmus, and equal tracking)
Lack of smooth pursuit (left and right eyes)

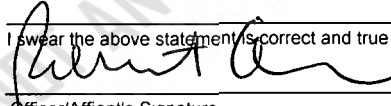

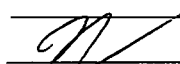

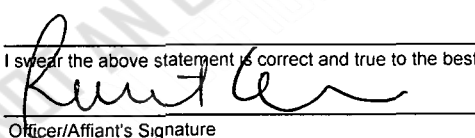
Probable Cause Affidavit

Before me this date personally appeared ODOR, ROBERT (18133) who being first duly sworn deposes and says that on 21 day of January (year) 2021 at 6300 N FEDERAL HWY, FORT LAUDERDALE, FL 33308 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows
to move his hand towards his face Moved head more than one inch

Modified Romberg balance
Estimated 37 seconds as 30 seconds
OBSERVATIONS Did not say stop

Based on the totality of the circumstances, I made the determination that the defendant was under the influence of alcohol and/or a chemical substance, and/or a controlled substance to the point his normal faculties were impaired As a result, I informed the defendant he was under arrest for DUI I then requested a breath test, at which time he asked what the consequences would be I then read the defendant the Florida Implied Consent Law and he agreed to the breath test I then transported the defendant to the BSO Breath Test Center During the transport the defendant stated that he drank two beers Breath tech operator Gray CCN# 10841 administered the breath test and conducted a 20 minute observation period The results were 119% BAC and 125% BAC The defendant was polite and cooperative during his arrest
