The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
The defendant was observed driving a black Honda 4D bearing FL tag LSHW83. The vehicle was observed weaving in its lane, causing its tires to drive along the lane dividers at several times, and jerking to correct. The vehicle would vary in speeds and was paced at 50 mph in a 35 mph zone approaching Kennedy Bv W / Hyde Park Av S. I conducted a traffic stop on the vehicle for the speeding violation as well as to check on the welfare of the driver as I was concerned they were sick, injured, or impaired. Upon contact, the defendant exhibited indicators of impairment to include a bar bracelet on her wrist, slow speech which was slurred at times, the odor of an alcoholic beverage emanating from her breath, glassy eyes, unsteadiness on her feet and admission of drinking. The defendant participated in SFSE's which showed further indicators of impairment and was subsequently arrested for DUI.

The defendant was ID'ed via FL DL.
