She was parked at Starbucks, located at 502 E Hillsborough Av. Contact was made as she was unconscious while in actual physical control of her vehicle which was running with keys in the ignition. A traffic stop was made and upon contacting the defendant she displayed multiple indicators of impairment, to include an odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol one glass of wine. The defendant performed SFSEs, and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the implied consent warning. The defendant was identified by her FL DL.
