	Upon our arrival, Officers made contact with the caller, [REDACTED] (W/F,04/20/1992) who advised the following during an audio and video recorded sworn statement: [REDACTED] Ilmyrat Kakajenov (W/M,10/24/1990) have [REDACTED] [REDACTED] Today, around 2230 hours, [REDACTED] was watching television in the living room as Ilmyrat ate dinner and the children sat/played on the rug. [REDACTED] advised [REDACTED] (W/F,12/16/2019) observed [REDACTED] was drinking water and asked for some. [REDACTED] did not want [REDACTED] to have water therefore she did not give [REDACTED] the water. Due to not being given water, [REDACTED] proceeded to beg for water while crying and having a small temper tantrum. This caused [REDACTED] and Ilmyrat to get into a minor verbal dispute about the child constantly having her way. Ilmyrat told [REDACTED] to get up and give the child some water, therefore [REDACTED] hesitantly obliged. Once receiving the bottle of water from the kitchen, [REDACTED] walked back to the living room and placed the water on the couch while stating shove it up your ass to Ilmyrat in Turkish. This caused Ilmyrat to become upset at which time he followed [REDACTED] to the bathroom where Ilmyrat physically made contact with [REDACTED] nose causing it to bleed. During the physical encounter Ilmyrat also placed his hand around the front of [REDACTED] throat, however [REDACTED] was able to breathe normally and never lost consciousness. Eventually the incident de-escalated, [REDACTED] cleaned her nose up in the bathroom, attempted to complete an online Police report but was unable to at which time she called Police for assistance with documenting the incident. [REDACTED] showed your writer approximately three digital photographs on her Apple iPhone which depicted [REDACTED] with a bloody nose and blood on her hands. These photographs all had a timestamp from today, July 10th, 2022, around approximately 2230 hours. A visual inspection of [REDACTED] revealed her nose appeared to be slightly swollen but no blood was observed inside or on it. Your writer made contact with Ilmyrat Kakajenov (W/M,10/24/1990) and conducted an audio and video recorded fact-finding interview at which time Ilmyrat provided a statement which appeared to be consistent with the statement received from [REDACTED]. During the statement, Ilmyrat advised he became upset after [REDACTED] said the bad Turkish word to him. Ilmyrat admitted he followed [REDACTED] to the bathroom, grabbed her by her wrists and placed his nose against [REDACTED] nose causing it to bleed. Ilmyrat also admitted that he placed his hands around [REDACTED] neck. Ilmyrat stated he became very upset and lost his composure, therefore he was wrong. A visual inspection of Ilmyrat revealed he had approximately four small abrasions on his left forearm. Ilmyrat also had two small abrasions on the left side of his neck. As a result of this investigation probable cause exists to charge Ilmyrat Kakajenov (W/M,10/24/1990) with one count of Simple Domestic Battery per FSS 784.03(1A1).

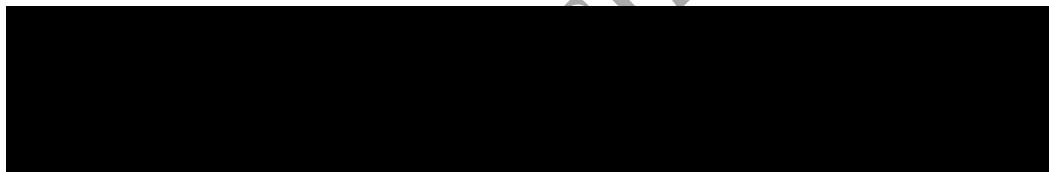
