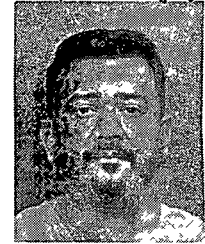

Before me this date personally appeared GUZMAN, JOSE M (18795) who being first duly sworn deposes and says that on 15 day of February, (year) 2022 at 1899 SW 10TH ST/S MILITARY TR, DEERFIELD BEACH, FL 33442 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Upon arrival Dep Silva advised he observed the defendant behind the wheel of his vehicle Dep Silva advised he conducted a traffic crash investigation which revealed the defendant was traveling westbound on SW 10th St at a high rate of speed over the I95 overpass bridge The defendant struck several vehicles when his vehicle came to a stop after striking the vehicle in front of him No injuries were reported by Deerfield Beach Fire Rescue Dep Silva advised he observed the following signs of impairment red glossy eyes, very slurred speech and a strong odor of alcoholic beverage coming from his breath Dep Silva requested me on scene to conduct a criminal DUI Investigation

During my encounter with the defendant, I observe the following signs of impairment red glossy eyes, extremely slurred speech, and a strong odor of alcohol emitting from the defendant's breath I advised the defendant Dep Silva had concluded the traffic crash investigation and I was conducting a separate DUI Investigation I asked the defendant where he was coming from, the defendant advised he was coming from Fort Lauderdale I asked the defendant what he was doing there, the defendant advised, "chilling" I asked the defendant if he had any drinks tonight, the defendant initially advised no but then changed his answer to had consumed some whiskey I asked the defendant to step out of his vehicle and follow me to the front of my vehicle which was located behind the defendant's vehicle about 20 feet apart

Once the defendant exited the vehicle the defendant used the driver rear quarter panel to assist him with walking The defendant used his left hand and arm to lean on the vehicle for balance As the defendant was walking over to my car, the defendant was stumbling and would cross his feet I asked the defendant if he was willing to do some field sobriety exercises, the defendant advised no at first and after explaining the

- Subject paused while walking Paused after nearly falling three times
- Did not touch heel-to-toe Missed every step forward and back
- Stepped off line several times
- Raised arms for balance the defendant's hands where up during the entire exercise
- Incorrect number of steps Forward 14 & Back 13
- Incorrect turn
- Did not count footsteps out loud
- Did not look at feet while walking
- Did not perform exercise as instructed (The defendant crossed his feet several times which caused him to nearly fall and stumble)

- Started before being instructed
- Did not keep head tilted back
- Did not keep eyes closed
- Failed to return arms to side
- Missed finger to nose
- Swayed while standing
- Did not perform exercise as instructed (The defendant could not complete the exercise, the defendant moved his left hand further back when I said left and then would turn his head left and attempted to touch his nose)

*** Romberg Balance**

- Swayed while standing
- Eyelid tremors
- Lost balance while standing
- Opened eyes after 22 seconds

Next, I determined there was probable cause to arrest the defendant for DUI After being handcuffed, I asked the defendant to submit to a breath test

The defendant consented to the breath test, and following a twenty minute observation period, the defendant provided two valid breath samples (0 204 BrAC & 0 210 BrAC)
