Probable Cause Affidavit

Before me this date personally appeared CALDERON, ANDREA C. (18803) who being first duly sworn deposes and says that on 23 day of September, (year) 2021 at 5221 SR 810, COCONUT CREEK, FL 33073 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

To wit: On September 23, 2021, at approximately 0102 hours, I responded to the 5201 SR 810 in reference to an unconscious female inside an Uber vehicle. Upon arrival, the female (the defendant) regained consciousness and appeared heavily intoxicated from an unknown alcoholic beverage and/or narcotic; she had slurred speech, bloodshot eyes, the smell of an unknown alcoholic beverage was emanating from her person, and she stumbled while attempting to walk and/or stand up straight. While escorting her back to her residence at 5221 SR 810 #303, officers on scene, myself included, attempted to keep her from falling on numerous occasions due to the defendant being unsteady on her feet and unable to maintain her balance. While doing so, the defendant became irate and physically aggressive towards officers on scene as she continuously and actively began to pull back and punch out her arms against any officers's efforts to calm her down and maintain her afoot. Additionally, the defendant began hysterically crying, yelling and screaming at officers, and ultimately and deliberately punched myself and Ofc. M. Baker on the mid to left side of our chest area with her right hand. While subsequently attempting to place the defendant into police custody, she actively and physically resisted our efforts to place her in handcuffs by kicking, forcefully moving her arms, and walking away from officers. As we placed her inside my marked police vehicle (Unit # 1417), the defendant continuously and with strong effort began kicking the rear passenger side window and door. The defendant was consequently transferred to a half-cage unit (Unit # 1487) in an effort to prevent her from breaking any vehicle windows and/or doors.

Based on the fact that the defendant deliberately struck Ofc. M. Baker and I, she was charged with two (2) counts of Battery on L.E.O per F.S.S. 784.07-2B, Resisting Arrest with Violence per F.S.S. 843.01(HG), and Disorderly Intoxication per F.S.S. 856.011
