Probable Cause Affidavit

Before me this date personally appeared Det. Tom Butt, who being first duly sworn deposes and says that on the 5 day of September, (year) 2017, at (crime location) 741 E. ACRE DRIVE PLANTATION, FL, the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

On Sept. 5, 2017, at approximately 0140 hours the victim [REDACTED] went to the defendants (Coppee) home to have a police report made [REDACTED] advised that Coppee has been stalking and harassing him via texts, phone calls and driving by his house repeatedly, after he had told her to stop. [REDACTED] advised he called 911 before arriving at the home of Coppee, so that the police could meet him there to tell her to leave him alone and to make a report so she would know he was serious. [REDACTED] was on the phone with dispatchers when he arrived at the home. [REDACTED] advised he told Coppee he was coming over to her house 10 minutes prior to his arrival after she had called him earlier. Upon his arrival he parked his vehicle on the swale with his headlights pointing at the house to illuminate the house numbers. He exited his vehicle and got to the sidewalk when she (Coppee) exited her vehicle (a black Jaguar) with a gun in her hand. [REDACTED] was suprised because her vehicle was not running

**Probable Cause Affidavit
(Continuation)**

Before me this date personally appeared Det. Tom Butt, who being first duly sworn deposes and says that on the 5 day of September, (year) 2017, at (crime location) 741 E ACRE DRIVE PLANTATION, FL, the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

and he immediately noticed a large silver revolver in her hands pointing directly at him. He backed up and she was screaming at him to leave. He backed up and went behind his vehicle. She approached him with gun in hand and slapped him in the face, then held him at gunpoint while she was reaching into his car in an attempt to steal his keys from the ignition, to prevent him from leaving. Coppee later stated she wanted to take his keys and throw them in the bushes to deprive him of his keys. While she was reaching for his keys [REDACTED] grabbed the firearm with his right hand. Coppee pulled the trigger, firing the gun, while they were both leaning into the vehicle. While still holding the gun possibly, 3 more shots were fired while they were leaning into the vehicle. The victim [REDACTED] advised that Coppee was trying to force the barrel toward his body while she was pulling the trigger in an attempt to shoot him and that he feared for his life. He wrestled the gun away from her and the victim ran back into her home. He placed the gun on the roof of his car just as police showed up. After a SWAT 6 hour standoff the defendant exited her home and was placed into custody. Sworn taped statements were taken from the victim and the defendant's mother. Mirandized statement was taken from the defendant as well. The victim and defendant have previously been intimate with each other approximately 6 months ago. The victim has a girlfriend and has repeatedly told the defendant to leave him alone.
