The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/29/2022 at approximately 1613hrs, Affiant conducted a vessel stop on a white 33' Black Hawk boat bearing FL6896R7 /HIN: OUG33099I607 for improper display of registration numbers (citation #V374887) and for a safety inspection. Upon stopping the vessel, affiant made contact with the operator/defendant, who was sitting at the helm. During personal contact with the defendant, affiant observed him to have blood shot watery eyes and detected an odor of an alcoholic beverage coming from his breath as he spoke. Based on this, affiant requested the defendant perform seated sobriety tasks to determine if he was operating a vessel while under the influence of an alcoholic beverage and/or controlled/illegal substance. The defendant agreed to the tasks. Based on observations of impairment, the defendant was arrested for BUI and secured in handcuffs (1635). The defendant was transported to the Hillsborough County Sheriff's Marine Office, where Florida Fish and Wild Life had their breath alcohol trailer. The defendant was advised Florida Implied Consent (1652hrs) and agreed to provide a breath sample. After a 20-minute face to observation period, the defendant provide samples of .247 /.241. The defendant was transported to the Orient Road Jail without incident.
