The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was operating a white 2018 Mercedes, 4 door, Florida tag 65BDHP. The defendant drove in a manner in which the vehicle drifted over the left center painted lane marker. The defendant accelerated to a very high rate of speed as he traveled at speeds in excess of 90 MPH in a properly posted 40 MPH speed limit. The speeds were visually estimated (I am a certified radar/laser operator), and was patrol car paced (TPD DUI unit 5055). The defendant attempted to avoid apprehension by speeding through a hotel parking lot, parking quickly and exiting the vehicle. The defendant parked at an angle across two parking spaces. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant denied alcohol consumption. The defendant's eyes were bloodshot, glassy, and watery. The defendant's speech was slurred and his face was flushed. The defendant's cognitive abilities were poor as he had difficulty remembering information and following simple instructions. The defendant swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and had difficulty following simple instructions. Based on a totality of the circumstances the defendant was arrested for DUI. The defendant refused to submit to a lawful test of his breath for the purpose of determining its alcohol content after being read the Implied Consent Warnings. The defendant was positively identified by his Florida DL. Post arrest the defendant became verbally abusive, hostile, demeaning, and insulting.
