 On 12/04/2021, at the location within Hillsborough County, the defendant and victim were involved in a physical altercation, where the defendant struck the victim in the arm, and then on the left side of the victim's face, with a closed right fist, against the victim's will. The victim suffered visible injuries, including swelling to her left arm, a bruised left eye, and a red mark above her left eye. The victim required to be seen by EMS for the bruising to her left eye (HCFR run# 21-812475). The victim was not transported by EMS to the hospital, and requested that her friends take her. The defendant and victim have been in a romantic relationship for approximately two years, and have lived together for approximately a year.
