The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was operating a blue 2013 Hyundai Elantra, 4 door, Florida tag DBWU34. The defendant failed to come to a complete stop at a properly posted stop sign, and drove at speeds that were visually estimated and patrol car paced (TPD DUI Unit 5055) at 60 MPH in a properly posted 40 MPH speed limit and 47 MPH in a properly posted 30 MPH speed limit. A traffic stop was conducted. The defendant had a distinct odor of an alcoholic beverage coming from her breath. The defendant wore a paper bar admissions band (bright green with white dots) on her right wrist, and she stated she was coming from Tangra (a night club). The defendant denied consuming alcoholic beverages and could not explain the odor coming from her breath. The defendant's eyes were bloodshot and watery, and her face was flushed. The defendant's speech was initially mildly slurred. The defendant was unsteady exiting the vehicle, and she swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances she was arrested for DUI. The defendant refused to submit to a lawful test of her breath for the purpose of determining its alcohol content after being advised of the Implied Consent Warnings. The defendant was positively identified by her Florida DL.
