The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the listed date and time, the victim was working in Ybor City as a fully uniformed Tampa Police Officer. [REDACTED] was wearing a dark blue City of Tampa issued uniform with City of Tampa patches on both shoulders and badge displayed on the upper left chest. The victim was breaking up a fight at N 16th St/E 7th Ave at which time the defendant struck the victim in the forehead with a closed right fist, splitting the victim's forehead above his eye and causing [REDACTED] to bleed. The victim pushed the defendant away at which time the co-defendant grabbed [REDACTED] by his outer carrier vest and began shoving [REDACTED] as well as ripping [REDACTED] radio mic off [REDACTED] vest, thus depriving [REDACTED] the use of [REDACTED] radio. The defendant and co-defendant were subdued and taken into custody without further incident. The defendant was positively identified via DHSMV photo.
