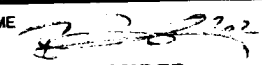

On 05-19-2022 at approximately 0306 hours, Officer Holloway was dispatched to Casa Del Rio located at _____ in reference to a physical altercation that was called in by an anonymous caller. Upon arrival, I observed a white male wearing all black clothing walking eastbound on the sidewalk in front of the apartment complex. I made contact with the male and observed him to have blood around his mouth. The male was later identified by his FLDL as Jake Birkhahn. Birkhahn stated that he and _____ were driving near the area of 2200 NW 5th Avenue in a black 2023 Dodge Charger bearing FL tag # LLJI72. The two got into a verbal argument and _____ exited the vehicle leaving his cellphone in the vehicle with Birkhahn. Birkhahn went through _____ cellphone and discovered that _____ had been texting _____ Birkhahn held _____ cellphone up to the window showing him what he discovered. _____ walked to the driver side of the vehicle and started to strike the window with closed fist. _____ then walked in front of the Charger and sat on the hood. Birkhahn stated that he knew _____ was on the hood, so he intentionally drove southbound at an unknown speed with him there, not caring if he got hurt, causing _____ to fall off the vehicle, landing on the asphalt. _____ sustained minor lacerations to his right elbow and right ring finger. Birkhahn stated that he drove to the apartment complex and backed into a parking spot located in front of building _____. _____ walked to the apartment complex, where he then encountered Birkhahn in front of the building. Another verbal argument occurred, while _____ put the code in to unlock the door of the building. As soon as the door unlocked, Birkhahn reached out to the door while _____ was standing in front of the door and held it closed, so _____ could not get into the building. Birkhahn stated that he struck _____ with an unknown hand and the two began to physically fight. After a few moments, Birkhahn and _____ separated and Birkhahn took a walk westbound on NW 20th Street where I then encountered him.

N	Birkhahn denied needing any medical attention. Photos of Birkhahn's mouth were taken with my BWC while at Boca Raton Police Department. I made contact with [REDACTED] confirmed that he and Birkhahn got into a verbal altercation in the car while in front of 2200 NW 5th Avenue. He exited the vehicle and proceeded to walk southbound on NW 5th Avenue in the bike lane. As he was walking, he stated that Birkhahn hit him with the Charger at an unknown speed and drove towards the apartment complex. Once he arrived at the complex, he attempted to put the code into building [REDACTED] and Birkhahn walked up behind him attempting to keep the door closed by holding it with his hand. Birkhahn then proceeded to swing a closed fist at [REDACTED], which he dodged then punched and struck Birkhahn in the face with a closed left fist. [REDACTED] and Birkhahn proceeded to physically fight. [REDACTED] denied needing any medical attention and stated that he was fine. I observed [REDACTED] to have a small laceration to his right elbow and right ring finger. I took photos with my BWC prior to leaving Casa Del Rio. I made contact with the 2023 black Dodge Charger that was used as the weapon in this incident and observed handprints along the hood of the vehicle. I also observed what appeared to be a smudged mark as if a body was dragged across it, along with blood and handprints on the driver window. Photos of the vehicle were taken with my BWC. I asked [REDACTED] about the handprints on the driver window, and he stated that he did not remember hitting the window at any time during this incident. At the conclusion of my investigation, I found Jake Birkhahn to be the primary aggressor and charged him with Aggravated Battery (Deadly weapon) FSS 784.045(1A2), being that he intentionally struck [REDACTED] with his black Dodge Charger, having no regard for life or injuries. Birkhahn was transported to Palm Beach County Jail.
