The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 4/2/2022 at approximately 0100 hours, your affiant observed the defendant operating a white Ford Escape bearing FL tag GKMS16, northbound on Dale Mabry Hw near Mapledale Dr. The defendant was traveling 66 mph in a 45 mph zone. I conducted a traffic stop and made contact with the driver/defendant. Upon contact with the defendant, I observed watery glassy eyes, mildly slurred speech, and the strong odor of an alcoholic beverage emitting from the vehicle. I asked the defendant to complete SFSE's and he agreed to the HGN exercise. During the HGN exercise, the defendant displayed several indicators of impairment. I asked the defendant to complete the walk and turn exercise and he was hesitant. The defendant entered the starting position and was very unsteady on his feet and losing his balance. The defendant left the starting position and then determined he did not want to complete the remaining SFSE's. Based upon the indicators of impairment, I made a totality of the circumstances decision and placed the defendant under arrest. Once at CBT, the defendant refused to provide the lawfully requested breath samples after being read implied consent in CB-01. I issued the defendant DUI citation AFYJMXE for DUI and UTC AFYGSOE for Speeding. The defendant identified himself via FL DL.
