The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 06/08/2022, at the Hilton Garden Inn which is located at 10309 Highland Manor Drive, Tampa, Florida 33610 the defendant was observed by Deputy J. Richter ABN: 260940 operating a black 2018 Chevrolet Truck bearing Florida tag QCM8L with an assigned VIN of 3GCUKPEC3JG465537 stopped at a steady green light and furthermore appearing to be tired, ill, or impaired while driving through several intersections. Upon Deputy Richter's contact with the defendant, he observed multiple indicators of impairment. While in direct contact with the defendant, I observed him to have bloodshot watery/glassy eyes, he had slurred speech, he was slightly unsteady on his feet and I smelled the strong odor of an alcoholic beverage emitting from his breath. The defendant participated in the field sobriety exercises, and while doing so he demonstrated further indicators of impairment. After taking the totality of the circumstances and the defendant's indicators of impairment into consideration he was placed under arrest for DUI. The defendant was transported to Central Breath Testing and he refused to provide two lawful breath samples. As a result, he was read Implied Consent and he continued to refuse by stating "No, I need to talk to my fucking lawyer first." I further identified the defendant via his DAVID photograph.
