The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 07/05/2022 at approximately 0108 hours, TPD Ofc. H. Donahue conducted a traffic stop on a silver 2006 Toyota sedan with Florida tag Z26FPG at the intersection of Dale Mabry Hwy N and Kennedy Blvd W after the vehicle attempted to make a lane change into the travel lane occupied by her police patrol vehicle and she has to make a evasive maneuver to avoid a traffic crash. TPD Ofc. H. Donahue made contact with the driver/defendant, observed indicators of impairment, and requested a DUI investigation be conducted.

I responded to the scene and made contact with the driver/defendant who was observed to have bloodshot/glassy eyes, slurred speech, was confused as to where he was/where he was going, had a noticeable sway while standing, and had the odor of an alcoholic beverage coming from his breath. The defendant exhibited clues of impairment during SFSTs and was arrested for DUI. The defendant submitted to the requested breath testing which produced a BrAC of 0.155/0.145.

During the inventory search of the vehicle, a empty vodka bottle was located in the center console.

The defendant was positively identified via DHSMV photograph.
