NARRATIVE:

SUPPLEMENTAL PC

On 07/27/2022 at approximately 0052 hours, I was patrolling the area of the 11000 block of Okeechobee Blvd. in the Village of Royal Palm Beach, Palm Beach County, FL. While doing so, I observed a red Ford Escape SUV, bearing PA Tag #LVS-6435, parked behind the businesses at 11328 Okeechobee Blvd., facing south, with the lights on.

The businesses at this plaza are all closed at this hour and the area the vehicle was parked was not a parking spot. Upon closer inspection, I observed the vehicle to be parked with the front bumper against a fire hydrant water valve system. I pulled behind the vehicle and ran the tag to which FCIC/NCIC reported it was an Enterprise rental. I exited my patrol vehicle and approached the vehicle. I immediately observed a white male driver to be the sole occupant of the vehicle and asleep behind the wheel with the transmission still in "Drive". I attempted to wake the male for several minutes by knocking on his window with my hand, flashlight, and baton. Despite numerous attempts, the male did not wake up.

D/S Rivas arrived on scene and we continued to attempt to wake the driver. As we were about to break the window fearing that he was having a medical emergency, the male woke up and stared at me with extremely red and glassy eyes. I told the male to open the door to which he took about 10-15 seconds, but finally did. Upon opening the door, the male appeared to be extremely confused and had slurred and slow speech. I asked the male what happened, to which he stated that he didn't know. I asked the male for his driver's license to which he handed me an American Express credit card, followed up by another credit card, and finally cash. D/S Rivas pointed the male towards the driver's license, to which it took him several minutes to pull the license out of his wallet. Upon finally getting the license out, it was determined to be a Tennessee DL identifying the subject as Jami Golden. Golden stated that he owned the car but was unable to provide registration or insurance. Golden further stated that he didn't know where he was, didn't know how he got there, and didn't know where he was coming from.

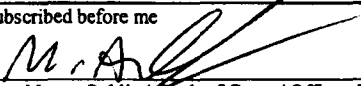
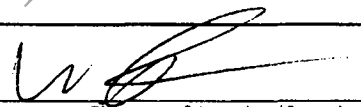
Golden was wearing a dress shirt and slacks, with a sports jacket hanging from the back of his driver's seat. His movements were slow and deliberate while lacking in dexterity (often taking him several attempts to do small things like open the glove box or center console). Golden was asked if he had any medical issues, to which he confirmed that he did not. Golden was asked if he had any alcohol or drugs this evening, to which he stated "not that I know of."

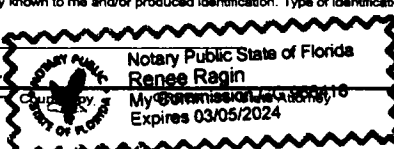
At this point, the following was observed of Golden:

1. Extremely red glassy eyes
2. Slurred/slow speech with delayed responses
3. Slow/deliberate movements
4. An pronounced lack of dexterity
5. Confusion as to his current whereabouts and actions
6. Confusion as to the vehicle being a rental or owned by him
7. Confusion as to his movements, intentions, and destination
8. Unusual parking/operation of his vehicle, including obstructing a fire hydrant valve system
9. Stated he has no medical issues
10. Sleeping behind the wheel while the vehicle was still in "Drive"

Based on these facts, I suspected the driver to be impaired. I then requested that D/S M. Alexander to respond in order to conduct the DUI investigation.

Upon his arrival, the ongoing investigation was turned over to D/S Alexander without incident.

Art.1 § 16(b) On July 27, 2022 at approximately 0110 hours, I responded to 11328 Okeechobee Blvd in The Village of Royal Palm Beach, Palm Beach County FL, 33411 in reference to an unresponsive male in a vehicle. Upon my arrival I spoke with Sgt. Manning id #13558. Sgt. Manning stated that he found the vehicle parked behind the business with the driver sleeping behind the wheel, with the car still in drive, resting against a fire hydrant valve system. Sgt. Manning suspected the driver of DUI and called me to respond and conduct a DUI investigation. See Sgt. Manning's supplemental PC for further. Upon making contact with Golden who was sitting in his vehicle of I observed the following: 1. Extremely red glassy eyes 2. Slurred/slow speech with delayed responses 3. Slow/deliberate movements 4. Confusion as to his current whereabouts and actions 5. Unusual parking/operation of his vehicle, including obstructing a fire hydrant valve system Golden was speaking to other deputies on scene and saying he had no recollection of how he got to where he was and suggested it was an "alien situation" Golden kept saying "I really don't know where I am or how I got here, this is crazy." In speaking with Golden he stated the following: He arrived at Ft. Lauderdale International Airport on 7/26/22 in the morning. He could not remember what occurred between his arrival into Florida until speaking with me. He was staying at the Hampton Inn in Wellington Florida approximately 7 miles away from where he was located and could not elaborate any further. Upon suspicion of DUI, I requested that Golden conduct field sobriety tasks. I explained to Golden that I was conducting a DUI investigation and requested that he submit to field sobriety tasks to which he agreed.

Upon performing the task, it was noted that he had involuntary jerking at the onset of the task along with at the 45-degree mark and at maximum deviation it was very pronounced. WALK AND TURN did not follow instructions, did not keep hands to the side as instructed. Raised his arms out multiple times, could not walk the solid yellow tape. One Leg Stand- The Defendant was placed into the instructional stance for one leg stand and could not keep balance, almost falling over couple times. Hand Coordination- The Defendant was placed into the instructional stance for hand coordination. Subject was shown the instructions multiple times, and could not understand the instructions given. Subject put tip of finger on the bridge of the nose. Romberg Alphabet- Subject was unable to recite the alphabet and chose to count until told to stop. Subject counted too fast after being told to recite it slowly. Golden was arrested for suspicion of DUI. While at the breath testing unit a twenty-minute observation was conducted. Upon completion of the observation period the defendant was escorted to the testing area for obtaining a breath sample of which he provided. I then read his rights to him verbatim which he acknowledged he understood them and provided a breath sample which yielded a test result of .222 and .228. Golden stated post Miranda he had been drinking at several restaurants in the surrounding area stating "I had few to many cocktails". Upon doing Golden's prisoner property a receipt for \$17.64 for Buffalo Wild Wings (a bar) was found in his wallet. Based on my investigation I determined that Jami Golden committed the following crime: DUI - by knowingly and willfully operating a motor vehicle within the State of Florida while under the influence of an unknown substance contrary to FSS 316.193.

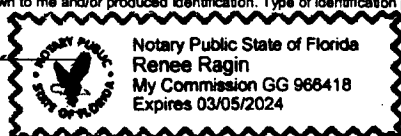
