The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above listed date, time, and location, I made contact with the defendant on a traffic crash investigation (HCSO 22-250780 / DHSMV:24636108) where the defendant was involved in a traffic crash causing approximately \$14,000 in property damage. The witness positively identified the defendant as the person operating the vehicle at the time of the crash. Upon contact with the defendant, indicators of impairment were observed to include bloodshot glassy eyes, slurred speech, unsteady balance, and the odor of an alcoholic beverage emitting from her breath. Standardized Field Sobriety Exercises were started however, the defendant refused the opportunity to continue the Standardized Field Sobriety Exercises after being explained the consequences. Based on the totality of the circumstances, the defendant was arrested for DUI. The defendant refused to provide lawful breath sample after Implied Consent was read. The defendant was identified via her FL DL.
