The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: At the above-listed date and time, I Trooper B.E. Longmire responded to a crash on Brandon Blvd. I was driving east Brandon Blvd when I observed two vehicles that appeared to have been in a traffic crash blocking the outside lane. I had both parties move to a CVS parking lot which was only a few feet away on the left. I spoke to the driver of vehicle #1, a Dodge Ram pickup truck. The driver was identified by his Florida driver's license as Jarred Anderson Chandler. I could smell an odor of an alcoholic beverage coming from his breath. Mr. Chandler was unsteady on his feet and used the vehicle to balance himself. Mr. Chandler would only get out of the car when directed. At the conclusion of my crash investigation, I read Mr. Chandler his Miranda rights and ask him some medical history questions. I asked Mr. Chandler to perform three standardized field sobriety exercises. Mr. Chandler performed the Horizontal Gaze Nystagmus. Walk and Turn and One-Leg Stand. Mr. Chandler performed the exercises in a manner that I believe he has consumed an amount of an impairing substance to the point that he was driving while impaired. The results of the breath test revealed a BAC of .267
