The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/19/2022 at approximately 2054 hours while at 9912 Menander Wood Ct, the defendant and victim got into a verbal altercation which turned physical when the defendant forcefully grabbed the victim's left arm against her will. The defendant then grabbed the front of the victim's sweater near the collar and attempted to drag the victim. The victim and defendant are married and have one child together (3 years old) who was present at the time of the incident. Post-Miranda, the defendant denied anything physical occurring. The victim identified the defendant as the person who committed the offense. The defendant's identity was confirmed via his Florida driver license photograph dated 06/07/2017.
