The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 04/09/2022, at approximately 0137 hours, Deputy R. Groves (ABN 258014) responded to the intersection of North US Hwy 41 and Whitaker Rd, in reference to a related battery call for service (HCSO case #22- 274923). Upon arrival, Deputy Groves made contact with the defendant, who was sitting in the driver's seat of a Ford F-150 (FL tag: 39BJQQ). While Deputy Grove was in contact with the defendant, he attempted to drive away. Upon contact with the defendant, he had bloodshot glassy eyes, slurred speech, unsteady balance and the distinct odor of an alcoholic beverage emitted from his breath as he spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he refused. Based on the totality, the defendant was placed under arrest for DUI. Implied consent (breath) was read and the defendant refused to provide a lawful breath sample. The defendant was identified via his Florida driver's license.
