Probable Cause Affidavit

Before me this date personally appeared CRUZ-GARCIA ANDRES A (2019), who being first duly sworn deposes and says that on 20 day of February, (year) 2022 at [REDACTED] (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

having relationship problems as of late and he was in the process of trying to evict her from the apartment. They are currently sleeping in separate bedrooms. On today's date, the victim came home from work and found that the def. had gone into her room and moved things around. The def. also removed all the light bulbs from in her room. She confronted the def. about this as he was seated on the couch in the living room. The def. would then get up and enter the victim's bedroom and began going through her purse. As the victim found the def. in her room she advised him to put her purse down and she also took a hold of the purse. A physical altercation then ensued. The def. wrestled the victim to the ground and mounted on top of her. The victim advised that the def. had a knife in his hand and made verbal threats to kill her. The victim stated that the def. said that because he was a dentist he knew exactly where to stab her to kill her. Eventually the def. would get off her and did not stab her.

Contact was re-established with the def. who voluntarily offered to show officer's video that he recorded himself of the incident. The video depicts the def. seated on the couch. The victim confronts him about the light bulbs being removed from her room. The def. then admitted that he removed the lightbulbs. As the victim walks away and into another room, the def. gets up from the couch and goes into the victims bedroom. The victim then yells at him to put her bag down. Both the victim and def. get into a physical altercation which leads to the ground. The victim is heard yelling for the def. to get off of her and her stating "you have a knife in your hand." The def. the follows up by acknowledging that he has a knife in his hand and states "yeah and I'll kill you."

After watching the video and establishing that the video confirms the victims account of
