The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a black 2018 Honda four-door bearing a Florida license plate of JFQA72. He was traveling west on Hillsborough Ave approaching a red light at Anderson Rd and caused a traffic crash when he failed to slow down and struck the rear of the victim's vehicle (victim was stopped at the red light). The defendant was positively identified as the driver at the time of the crash. Upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, flushed face, droopy eyelids, slurred speech, an odor of an alcoholic beverage, and an unsteady stance. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent warning. The defendant was identified by his by his FL DL.
