PROBABLE CAUSE

Before me this date personally appeared (Ofc A Pagano 883) who being first duly sworn deposes and says that on the (07) day of (09) (2017) at [REDACTED] the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows
The Victim and Def are married and reside together. Today the def was watching TV on the couch and asked the Victim for some water. The victim then tossed the water bottle towards the direction of the def. The water bottle struck a glass that was on the top of the couch and subsequently broke the glass. A piece of glass had inadvertently cause a minor cut on the def right middle finger. The victim felt bad and had put a band aid on the def finger. Approx two hours later the def went upstairs to the victim as she was in bed and intentionally threw a water bottle at her. The water bottle struck the victim in the head. You can see that the victim had water all over her shirt. The def stated that he was giving the victim water although the victim stated that she already had a bottle. The victim denied rescue and did not want to prosecute. The def was transported to Bso Main.
