The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was stopped for running a stop sign, weaving in and out of his lane, swerving, was slow to respond to a traffic signal, and driving more than 10 MPH below the posted speed limit. The defendant was driving a 2020 Lexus 4-dr, bearing FL tag #PKJZ43. Upon making contact with the defendant, he displayed multiple signs of impairment, including: bloodshot/glassy eyes, a strong odor of an alcoholic beverage on his breath, slurred speech, unsteady on his feet, staggering when he walked, swaying as he stood, was wearing a club admissions wristband on his right wrist, and made an admission to consuming alcoholic beverages. The defendant performed poorly on the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .149/.148. The defendant identified himself via his FL driver's license.
