who being first duly sworn deposes and says that on

2021 at 2099 BONAVENTURE BLVD/ROYAL P4LM BLVD WESTON, FL 33326 26 day of September, (year)

the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

and curb and struck and street sign as well as had a registration which had expired on 05/2021 (photos taken and uploaded to Evidence com) I then made contact with the driver and asked him if he had been drinking alcohol this evening and he just mumbled something incoherently that I could not make out I asked a few more times and he finally told me he had 2 beers but did not seem to know where he had consumed them While standing next to/speaking to the driver, I made the following observations of his physical condition Driver had a very strong odor, commonly associated with an alcoholic beverage, emanating from his nose and mouth, his eyes were watery/bloodshot, his face appeared flushed, and his speech was mumbled/repetitive/low/slurred/at times incoherent. At this time due to the nature of the accident, his admission of consuming alcohol, and my observations of impairment, I informed the driver I was now conducting a DUI Investigation and asked him to exit the vehicle and the driver just stared at me. I asked him again and he still did not comply I than ordered him out of the vehicle and he stepped out of the vehicle of his own accord When he exited the vehicle he appeared to have trouble maintaining his balance and appeared to swaying while standing still asked him to follow me to the front of my vehicle and he would take a few steps and stop and I had to keep encouraging him to follow me and at one point randomly pointed out my body camera for no apparent reason.

When we arrived at the front of my vehicle I activated my dash cam and asked the driver again if he had been drinking and he changed his response and stated he had 3 beers. I asked him multiple times where he had consumed the 3 beers he had mentioned and he could not provide me with an answer and initially just stared at me and then started saying that he was embarrassed over and over again I asked the driver who is a resident of the City of Weston, what road he was currently on and he could not tell me until he turned

26 day of September, (year) 2021 at 2099 BONAVENTURE BLVD/ROY4L PALM BLVD. WESTON, FL 33326 the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

around and read the street sign At this time I informed the driver I would be demonstrating and explaining 4 simple road side sobriety exercises and I asked him if he would be willing to perform them and he again just stared at me and did not respond. I asked him again and he still did not respond. I asked him if he was refusing the exercises and provided him with adverse consquences, informing him that if he did not perform the road side sobriety exercises, I had enough evidence to place him under arrest for DUI. The driver, ultimately identified as Jean Paul Figallo-05/28/1974, stated he would not perform the road side sobriety exercises and was placed under arrest for DUI. Two sets of handcuffs were provided to accommodate the drivers size/frame The Florida Implied Consent Law was read and I asked the driver if he would be willing to take a breath test and he refused The refusal warnings were read and he again refused to take the breath test. Deputy Ortiz began to escort the Suspect to his vehicle, and as he was passing me he apparently lost his balance and briefly stumbled into me The Suspect was placed into Deputy Ortiz's vehicle for arrest processing and upon completion was transported to the Broward County Main Jail for lodging. It should be noted that Deputy Castillo investigated the vehicle crash and completed an accident report in reference to this incident. See BWC for further information.
