The defendant was driving a 2016 white Dodge two door bearing a Florida license plate of HYZT19. She was traveling west on Kennedy between MacDill and Dale Mabry and unable to maintain a single lane, weaving back and forth. A traffic stop was made and the defendant was very slow to stop, upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, slow and sluggish movements, and a strong odor of an alcoholic beverage.
