Responded to a MVC where a truck driven by Jesse Parks IV, was reported to have backed into a parked vehicle. Witness, Paul Lormeus, did not see the crash, but was in the parking lot and heard it and responded to the scene, seeing an unoccupied Toyota (bearing FL - Y22MRY) attached to a gray Dodge Ram (bearing FL - 16GTZ). Lormeus stated he looked around the two vehicles and saw Parks sitting in the driver's seat. The keys were still in the ignition. Parks was identified via his Florida Driver's License

OBSERVATION OF DRIVER:

Bloodshot, glassy eyes, strong odor of alcohol, repetitive speech, unsteady on his feet, confusing statements.

DRIVER STATEMENTS:

Parks participated in the crash investigation. Post-Miranda stated he was at Voodoo Bayou where he had 8 Whiskey drinks, starting at 4pm. Parks claimed he was not driving, his car had not moved since he parked it at 4pm.
