The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a 2018 black Mercedes two-door bearing a Florida license plate of 10AEFH. She was traveling south on Bayshore Blvd near S Edison and caused a traffic crash when she rear ended the victims vehicle, which caused that vehicle to rear end victim two's vehicle. One victim suffered neck and back injuries and was transported to the hospital for treatment. The defendant was positively identified as the driver at the time of the crash. Upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, extremely slurred speech, slow and sluggish movements, a strong odor of an alcoholic beverage, very unsteady stance, an admission to consuming alcohol, and a drunk-like appearance. The defendant refused to perform SFSEs. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .282 and .289. The defendant was identified by her FL DL.
