The affiant observed a dark grey Chevrolet sedan bearing NY tag # JHU6638 traveling west on W Kennedy Blvd from N Armenia Ave. The affiant observed the vehicle swerving from left to right inside the lane three times prior to passing N MacDill Ave. The affiant then observed the vehicle drive onto the right white lane marker with it's passenger side wheels. The vehicle maintain the path of travel on the lane marker until the affiant conducted a traffic stop on the vehicle at W Kennedy Blvd / N sterling Ave. A traffic stop was conducted to check the welfare of the driver to determine if she were sick, tired, or impaired. The defendant had slurred speech and and fumbled through her wallet to produce her drivers license. The defendant then performed standardized field sobriety exercises and showed signs of impairment. The defendant provided a sample of her breath. The results were .14/.145.
