The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did Jessica Frederere drove her white Nissan Armada (FL EHWQ13) around a road closure sign and a marked police vehicle at E 7th Av / N 15th St. She was stopped a short distance later and verbally identified herself.
