The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 4/18/2022, at 2214 hours, the defendant was operating a blue Ford Escape, bearing FL tag 0322QZ (VIN: 1FMCU0F64MUA04835) while sitting at a red light at Paul Buchman Hwy / W Sam Allen Rd. The defendant observed a train coming and reversed her vehicle striking the witness's vehicle. The defendant was the sole occupant of the vehicle and the witness positively identified the defendant as the person who was operating the blue Ford Escape at the time of the traffic crash (22- 302359/ DHSMV # 24636875). Deputy C. Yockey ABN 260639 observed the defendant operating the vehicle and while speaking to the defendant she observed signs of impairment. The affiant responded to the scene and detected signs of impairment from the defendant, such as glassy / watery eyes, slurred speech, unsteady balance, and the distinct odor of an alcoholic beverage emanating from the defendant's breath. I requested the defendant perform Standardized Field Sobriety Exercises (SFSEs) which the defendant refused to perform. The defendant was then arrested for DUI based on the totality of the circumstances. I transported the defendant to Central Breath Testing (CBT). After a proper 20 minute observation period was conducted, the defendant agreed to provide two lawful samples of her breath. Breath technician A. Montgomery (ABN: 45673) provided the affiant with the results and they are as follows: first BrAC sample .137, second BrAC sample .141. The defendant was identified via FL DL.
