The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 7-30-2022, at 0418 hours, I was traveling westbound on Causeway Boulevard heading toward Falkenburg Road and observed a Acura MDX bearing FL tag AAHJ65 (VIN 5FRYD3H2XEB007186) traveling westbound unable to maintain its lane as it drove over the fog line several times and swerved within the lane. I conducted a traffic stop on the vehicle to check on the welfare of the driver (defendant). Upon making contact with the defendant, I observed him displaying indicators of impairment which included bloodshot glassy eyes, slurred speech, fumbling fingers, he was unsteady on his feet and I detected the odor of an alcoholic beverage emanating from his breath. The defendant performed field sobriety exercises and impairment was detected. I arrested the defendant for DUI and he provided two lawful breath samples, (.150) and (.158) after a twenty minute observation period. The defendant was identified via his Florida drivers license.
