The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a gray 2015 Nissan Pathfinder bearing a North Carolina license plate of JEF4416. He was traveling west on Kennedy Blvd between N Himes Ave and N Hubert Ave and was weaving back and forth. In addition, the vehicle accelerated for no apparent reason and was paced traveling 55 MPH in a posted 40 MPH zone. The speed was paced for a couple of city blocks and then the vehicle slowed down. A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol (two beers). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .136 and .134. The defendant was identified by his FL DL.
