The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was driving a 2019 GMC SUV bearing a Florida license plate of PCDE69. He was traveling east on I-4 between 22nd St and the Selmon connector and was driving on a right rear flat tire. The tire was completely shredded and the vehicle was traveling at highway speed (about 70 MPH). A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, and an admission to consuming alcohol (one Corona). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .118 and .111.

The defendant was identified by his FL DL.
