The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 06/15/2022 at approximately 0139 hours, TPD Ofc. D. Nadeau conducted a traffic stop on a 2015 silver Jeep SUV with Florida tag EEVX99 just east of the intersection of 22nd St N and Causeway Blvd after he observed the vehicle traveling approximately 68 MPH in a posted 45 MPH zone and the vehicle was unable to maintain a single travel lane. He made contact with the driver/defendant, observed indicators of impairment, and requested a DUI investigation be conducted.

I responded to the scene and made contact with the driver/defendant who was observed to have bloodshot/glassy eyes, slurred speech, difficulty responding to basic questions, had difficulty locating the requested paperwork, had the odor of an alcoholic beverage coming from his breath, and had a noticeable sway while standing. He admitted to drinking prior to driving. The defendant exhibited clues of impairment and was arrested for DUI.

After being read Implied Consent, the defendant submitted to the requested breath testing which produced a BrAC of 0.229/0.225. He was positively identified via DHSMV photograph.
