52 in Broward county FL Upon my arrival, I observed a white male sitting in his vehicle that appeared to have minor damage to the front of the vehicle. The passenger (wheel witness) of the other vehicle involved during the crash advised he witnessed the defendant, John Edward Urbach, who was later identified by his Florida drivers license driving the vehicle. I requested the defendant exit the vehicle and explain what happened in regards to the crash. The defendant had strong odor of an alcoholic beverage emitting from his facial area. The defendant also had slurred speech and swayed back and fourth constantly. After gathering information about the crash, I advised the defendant of his constitutional rights and advised him I was no longer conducting and crash investigation. I explained to the defendant I was investigating him for driving under the influence. The defendant waived his rights verbally and proceeded to speak with me. The defendant confirmed he was in fact driving at the time of the crash. The defendant advised he consumed multiple alcoholic beverages hours prior to the collision.

I requested the defendant perform FSE's which he complied. The defendant stated he did in fact have problems with his hips and legs but would perform the exercises. The FSE's were conducted roadside and my patrol car camera was activated. While the defendant was standing, he swayed in a circular motion. The defendant's speech was thick tongued and slurred.

Horizontal Gaze Nystagmus - The defendant had lack of smooth pursuit in the left and right eye, he had distinct and sustained Nystagmus at maximum deviation in the left and right eye, and he also had onset of Nystagmus prior to 45 degrees in the left and right eye

Walk and Turn - The defendant could not keep balance while listening to instructions; he aid not walk heel-to-toe, he stepped off the line, he did not count the proper steps, he did not count the loud

One Leg Stand - The defendant swayed while balancing, he used his arms to balance himself he put his foot down prior to 30 seconds elapsing and the exercise was terminated due to the defendant almost falling

The defendant was placed under arrest for driving while under the influence and was transported to the Broward County BAT facility where he provided a sample of his breathe to operator A Frazier with the Broward County sheriffs office
