Upon my arrival I came into contact with a road ranger who was helping change a tire on a vehicle. I came into contact with the driver of the vehicle who was identified as John Larkin (L625472774140) I asked the driver where he was coming from. Mr. Larkin stated that he was coming from the mall. Mr. Larkin. As I was speaking with the Mr. Larkin, I observed several indicators of impairment: Slurred Speech, Bloodshot watery eyes and a strong odor of alcohol emitting from his breath. I asked Mr. Larkin if he would be willing to perform field sobriety exercises to which he agreed. Mr. Larkin performed poorly on the exercises. Mr. Larkin was placed under arrest for DUI at 12:16 A.M. Mr. Larkin was asked if he would be willing to provide a breath sample to determine his blood alcohol content to which he declined. At 12:17 A.M Mr. Larkin was read implied consent Mr. Larkin still refused the test. Mr. Larkin was then transported to the Hillsborough county jail where he was booked under the charge of DUI.
