#### **Probable Cause**

On 7/3/2022 at approximately 1715 hours I, Officer David Morgan of Florida Fish and Wildlife Conservation Commission (FWC), and United States Coast Guard station Lake Worth were on water-based patrol around Peanut Island located in Palm Beach County inside of Palm Beach inlet. We observed a vessel operating on the displaying Florida dealer registration while using the vessel recreational. This is improper use of dealer registration. We initiated a vessel stop to address the violation.

Upon contact with the vessel operator, later identified as John Peter Kern Jr, FL DL# K65047502191 DOB 05/31/2002, I noticed that Kern had a slight odor of alcohol on his breath and glassy eyes. I explained to Kern the reason for the stop. When asked if he had consumed any alcohol today, due to the fact he was showing clues of impairment while under the legal age (21) of alcohol consumption, Kern replied he had consumed some alcoholic drinks.

I asked Kern if he would perform Seated Standardized Field Sobriety Tasks (SFSTs) to determine if he was impaired. Kern consented to perform Standardized Field Sobriety Tasks (SFSTs). I had Kern board the USCG vessel to begin Seated SFSTs.

I administrated the Horizontal Gaze Nystagmus (HGN), Finger to Nose, Palm Pat and Hand Coordination tasks in that standardized order.

During the HGN task Kern showed clues in both eyes. Lack of smooth pursuit as well as distinct and sustained nystagmus at max. Kern had 4 clues for the task. 4 or more clues indicate impairment.

The next task Kern performed was the Finger to Nose. I started by reading the instructions for the task. When told to begin performing the task and after he tilted his head back and closed his eyes, Kern started performing Finger to Nose without being told which hand to use. During the performance of the task, Kern had to be told to keep his eyes closed. On the first left, he did not use his fingertip (used pad of his index finger) and did not bring his hand down. On the first left, he searched his nose for the tip of his nose, did not use his fingertip (used pad of his index finger) did not bring his hand down after touching his nose. On the second left he did not bring his hand down after touching his nose (side of nose) and did not bring his hand down after touching his nose. On third right did not use his fingertip (used pad of his index finger) and did not bring his hand down after touching his nose. On the third left he used did not use his fingertip (used pad of his index finger) and missed the tip of his nose (side of nose). Kern had 17 clues for this task. 9 or more clues indicate impairment.

The third task I conducted was the Palm Pat. I explained the task instructions and demonstrated the exercise. I told Kern to begin the task after reading the instructions to him. During the performance of the task Kern showed clues of not increase speed until told to do so and had improper pat by not keeping rotated hand parallel to the bottom hand. In total Kern demonstrated 2 total clues on Palm Pat. 2 or more clues would indicate impairment.

The fourth task I conducted was the Hand Coordination. I explained the task instructions and demonstrated the exercise. I told Kern to begin after explaining the instructions. On the 1st task (Forward Steps) Kern performed with improper touch. On the 2nd task (Hand Clapping) Kern performed with improper count. On the 3rd task (Return steps) Kern performed with improper touch. On the 4th task (End position) he performed correctly. In total Kern demonstrated 3 clues on Hand Coordination. 3 or more clues would indicate impairment.

At the conclusion of the SFSTs, Kern was arrested for operating a vessel under the influence with normal faculties impaired at 1727 hours.

I transported Kern to Palm Beach County Main Jail at 1814 hours in my patrol vehicle. At the jail, Kern refused to provide a breath sample to determine his alcohol level. Kern was read the refusal of implied consent as well as the under 21 section of for refusal of breath sample. Kern acknowledge he understood what was read to him and again refused at 1842 hours. Kern refused post-Miranda questions.

(Misd.) 327.35(1)(a): Operating a vessel while normal faculties impaired

Citation 2: V663744

(Misd.) 328.52: Improper use of dealer registration

Citation 3: V663745

(Infraction) 327.355(1): Refusal to provide breath sample (Under the age of 21)

A person convicted of a violation of subsection (1) shall be ordered by the court to:

- (a) Participate in public service or a community work project for a minimum of 50 hours;
- (b) Refrain from operating any vessel until the 50 hours of public service or community work has been performed; and
- (c) Enroll in, attend, and successfully complete, at his or her own expense, a classroom or online boating safety course that meets minimum standards established by commission rule
