Upon arrival, Officer Goss was on scene and had already completed the traffic crash report (1709-000086). I made contact with the driver, John C Thompson, who was deemed as the at-fault person for the accident Thompson was sitting outside of the vehicle on the curb BSO Deputy Nicholas Sammarco was on scene at the time of the crash and observed Thompson behind the wheel of the black Honda (FL tag #DLAZ08). It should be noted no one was injured in the crash and that Thompson was the sole occupant of the vehicle While speaking with Thompson, I observed his eyes to be bloodshot. The strong odor of alcoholic beverage was coming from his breath and his speech was very slurred. I informed Thompson that the traffic crash investigation was over and that I was conducting a separate DUL criminal investigation.
