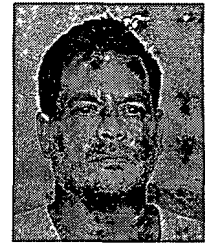

Probable Cause Affidavit

Before me this date personally appeared MICHAEL N BARANET II, who being first duly sworn deposes and says that on the 2 day of SEPTEMBER, (year) 2017, at (crime location) 1806 N PINE ISLAND, the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

On 09/02/17 I was dispatched to 1806 N Pine Island Road in reference to a DUI investigation. Upon arrival, Officer Goss was on scene and had already completed the traffic crash report (1709-000086). I made contact with the driver, John C Thompson, who was deemed as the at-fault person for the accident. Thompson was sitting outside of the vehicle on the curb. BSO Deputy Nicholas Sammarco was on scene at the time of the crash and observed Thompson behind the wheel of the black Honda (FL tag #DLAZ08). It should be noted no one was injured in the crash and that Thompson was the sole occupant of the vehicle. While speaking with Thompson, I observed his eyes to be bloodshot. The strong odor of alcoholic beverage was coming from his breath and his speech was very slurred. I informed Thompson that the traffic crash investigation was over and that I was conducting a separate DUI criminal investigation. I asked Thompson if he would be willing to perform roadside sobriety exercises at which time he agreed. -CONTINUED-

Before me this date personally appeared MICHAEL N BARANET II, who being first duly sworn deposes and says that on the 2 day of SEPTEMBER, (year) 2017, at (crime location) 1806 N PINE ISLAND, the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Prior to beginning the exercises I asked Thompson if he had any medical conditions that would prevent him from performing the field sobriety exercises which he responded no

The results of the roadside exercises were as follows

HGN I observed lack of smooth pursuit in both eyes Nystagmus was present at max deviation and onset prior 45 degrees

Walk and Turn Thompson started early before I instructed him to begin the exercise Thompson was using his arms to balance after instructing him to keep them at his sides Thompson was unable to place his heels to his toes in 2 separate steps Thompson missed the line 2 times on the first 9 steps with his left foot Thompson performed an improper turn taking his feet off the line On the next 9 steps he stepped off the line 2 times with his left foot and was again unable to place his heels to his toes in another 2 separate steps

One Leg Stand Thompson removed his hands from his side and used them to gain balance and raised them above 6 inches Thompson put his foot down 2 times and was swaying as he attempted to pick his foot back up

Based on my observations and all of the circumstances, Thompson was placed under arrest for driving while under the influence Thompson was read implied consent at which time he refused Thompson was transported to the Plantation Police Department for processing Officer A Pelosi responded to the jail to conduct a breath test See his supplement for further Thompson was then transported to BSO mail jail for booking
